## Minutes of the Louisville Public Schools Board of Education Special Meeting, May 15, 2020

The Louisville Board of Education conducted a Special Board meeting on Friday, May 15, 2020. In order to comply with the Directed Health Measure in place for Cass County, Nebraska, and in accordance with the terms of the Executive Order 20-03, "Coronavirus-Public Meetings Requirement Limited Waiver" ("Executive Order"), the meeting was held via videoconference and will comply with the requirements of the Nebraska Open Meetings Act, as modified by the Executive Order, and Neb. Rev. Stat. §§ 79-824 to 79-849.
